ROAD REHABILITATION AND DRAINAGE IMPROVEMENT WORKS: DUNBARS RIVER TO SMITHFIELD BRIDGE, WESTMORELAND

The National Works Agency invites eligible contractors to submit tenders for Rehabilitation Works: Dunbars River to Smithfield Bridge, Westmoreland. The works include but is not limited to demolition and site clearance, earthworks, drainage construction, road and pavement upgrades along the road section as specified.

Eligibility: It is mandatory that contractors be on the National Contracts Commission (NCC) List of Registered Contractors at the specified level in any of the following categories for their tenders to be eligible: Grades 1 or 2 in the Asphaltic Concrete Works, or General Road Works categories

Availability: Tender Documents will be made available **Thursday, November 12, 2015, until Thursday, December 03, 2015** at the National Works Agency's, Corporate Office, 140 Maxfield Avenue, Kingston 10 in the Directorate of Regional Implementation & Special Projects.

Fee: A non-refundable payment of J\$5,000 in cash or Managers' Cheque, payable to the Chief Executive Officer, National Works Agency, is required for each tender document.

Tender Security: A Tender Bond issued by a registered bank or insurance company in the amount of \$860,000 or a Manager's Cheque in the sum of \$430,000 made payable to the "Chief Executive Officer - National Works Agency".

Return of Tenders: Completed tenders along with the required documents: National Contract Commission (NCC) Certificate of Registration and a valid Tax Compliance Certificate (TCC), etc. are to be placed in an envelope labelled "**DUNBARS TO SMITHFIELD BRIDGE, WESTMORELAND**". The envelope should then be placed in the Tender Box similarly labelled and located in the reception area of the National Works Agency, Corporate Office, 140 Maxfield Avenue, Kingston 10. Tenders are to be returned no later than **10:00 a.m. on Monday, December 07, 2015.**

Tender Opening: The Tenders will be opened at **10:15 a.m., December 03, 2015** in the Main Conference Room, at the National Works Agency, Corporate Office, 140 Maxfield Avenue, Kingston 10. Tenderers or their representatives are invited to the opening.
