Invitation To Tender

TENDER FOR ROAD REHABILITATION WORKS: HATFIELD- HUNTLEY, MANCHESTER

The National Works Agency invites eligible contractors to submit **TENDERS FOR ROAD REHABILITATIVE WORKS FOR HATFIELD- HUNTLEY LOCATED IN THE PARISH OF MANCHESTER**. The works consist of Demolition and Site Clearance, Drainage Cleaning, Pavement Works - Asphaltic Concrete 38mm Thick, Asphaltic Concrete Sheet patching.

Eligibility: It is mandatory that contractors be registered with the Public Procurement Commission (PPC) List of Registered Contractors at the specified level in any of the following categories for their tenders to be eligible: Grades 1 or 2 in the Civil Engineering Works or General Road Works Categories.

Availability: Tender Documents will be made available as of **Monday, November 4, 2019**, at the National Works Agency, Corporate Office, 140 Maxfield Avenue, Kingston 10 in the Directorate of Regional Implementation & Special Projects.

Fee: A non-refundable payment of J\$5,000 in cash or Managers' Cheque, payable to the Chief Executive Officer, National Works Agency, is required for each set of Tender Documents.

Return of Tenders: Completed tenders along with the Bid Security (\$400,000.00) in the form of a manager's cheque from a local bank or tender bond from an insurance company. Public Procurement Commission (PPC) Certificate of Registration and a valid Tax Compliance Letter (TCL), are to be placed in an envelope labelled "ROAD REHABILITATIVE WORKS FOR HATFIELD- HUNTLEY, LOCATED IN THE PARISH OF MANCHESTER". The envelope should then be placed in the Tender Box similarly labelled and located in the reception area of the National Works Agency, Corporate Office, 140 Maxfield Avenue, Kingston 10. Tenders are to be returned no later than 10:00 a.m. on Tuesday, November 19, 2019.

Tender Opening: The Tenders will be opened at 10:15 a.m. on Tuesday, November 19, 2019, in the Regional Implementation & Special Projects Conference Area, National Works Agency, Corporate Office, 140 Maxfield Avenue, Kingston 10. Tenderers or their representatives are invited to the opening.

All queries concerning the Tender Document shall be made in writing and addressed to: **Moira Williamson, Major Projects Manager (Acting)**, National Works Agency, Corporate Office, 140 Maxfield Avenue, Kingston 10; by Tuesday, November 12, 2019.

Tenders not accompanied by a valid Tax Compliance Letter (TCL) and (PPC) Certificate of Registration will be rejected.
