### Invitation To Tender

#### TENDER FOR ROAD REHABILITATION: GAYLE AVENUE, ST. CATHERINE

The National Works Agency invites eligible contractors to submit tenders for **ROAD REHABILITATION GAYLE AVENUE LOCATED IN THE PARISH OF ST. CATHERINE**. The works consist of demolition, site clearance, earth works, drain cleaning, pavement works such as scarifying, preparation of formation, base course, application of asphaltic concrete overlay and ancillary works (kerbs and kerb & channels).

**Eligibility:** It is mandatory that contractors be on the National Contracts Commission (NCC)/Public Procurement Commission (PPC) List of Registered Contractors at the specified level in any of the following categories for their tenders to be eligible: Grade 1 or 2 in the Civil Engineering Works or General Road Works Categories. Tenderers must have a valid Tax Compliance Certificate (TCC).

**Availability:** Tender Documents will be made available as of **Tuesday, August 20, 2019**, at the National Works Agency, Corporate Office, 140 Maxfield Avenue, Kingston 10 in the Directorate of Regional Implementation & Special Projects.

**Fee:** A non-refundable payment of J\$5,000 in cash or Managers' Cheque, payable to the Chief Executive Officer, National Works Agency, is required for each set of Tender Documents.

**Return of Tenders:** Completed tenders along with a Bid Security (\$200,000.00) in the form of a manager's cheque from a local bank or tender bond from an insurance company, Public Procurement Commission (PPC) /National Contract Commission (NCC) Certificate of Registration and a valid Tax Compliance Certificate (TCC), are to be placed in an envelope labelled "**ROAD REHABILITATION WORKS GAYLE AVENUE LOCATED IN THE PARISH OF ST. CATHERINE**". The envelope should then be placed in the Tender Box similarly labelled and located in the reception area of the National Works Agency, Corporate Office, 140 Maxfield Avenue, Kingston 10. Tenders are to be returned no later than **10:00 a.m. on Tuesday, September 10, 2019**.

**Tender Opening:** The Tenders will be opened at **10:15 am on Tuesday, September 10, 2019**, at the Regional and Special Projects Conference table, National Works Agency, Corporate Office, 140 Maxfield Avenue, Kingston 10. Tenderers or their representatives are invited to the opening.

All queries concerning the Tender Document shall be made in writing and addressed to: **Maira Williamson, Major Projects Manager (Acting)**, National Works Agency, Corporate Office, 140 Maxfield Avenue, Kingston 10, by Monday, September 2, 2019.

Tenders not accompanied by a valid Tax Compliance Certificate (TCC) and NCC Certificate of Registration will be rejected.
